1. Public School Members pay a Member's Guest rate green fee of £25.00 per round or £35.00 per day.
2. They are allowed to bring guests, but guests pay half the normal green fee.
3. They cannot play in Club Competitions.
4. They do not have a vote.
5. They are entitled to purchase Club ties, Etc.
6. Their membership fee is currently frozen for life.
7. They can reserve tee times in the same way as full members.
8. They must live beyond a radius of 50 miles away from the Club.
